The Scottish Government published the <u>National Strategy for Economic Transformation</u> in March 2022. The strategy contains bold and ambitious actions to be taken over the next 10 years to deliver fairer, greener prosperity for all Scotland's people and places, and to make our economy more sustainable and resilient in the longer term.

The strategy's five policy programmes of action aim to increase Scotland's prosperity, productivity and international competitiveness. They include:

- stimulating entrepreneurship;
- opening new markets;
- increasing productivity and promoting regions;
- developing the skills we need for the decade ahead; and
- ensuring fairer and more equal economic opportunities.

<u>Delivery plans</u> were published in October 2022 setting out how the Scottish Government will work with partners to implement the 10 year strategy.
